#### Event/Course Rules

1. All runners must start at the designated starting line in their designated wave. Failure to do so may result in participation not being timed.
2. All runners shall attempt to complete every obstacle unless a demonstrated special circumstance exists, and is presented at check in.
3. Members of a group, team or family must start **and complete** the course together. IE 'no rabbits'!
4. All runners must stay on the marked course unless injured or leaving the course.
5. This event is a fun, family-oriented event. No horseplay is allowed on the course. Any runners involving themselves in horseplay will be disqualified and asked to leave the course grounds without refund.
6. Once you have finished the event, please move through the finish area and remain off the course. Do not re-enter the course or play (or allow children to play) on any obstacles.
7. Upon finishing, remove your shoe-tag and deposit in bucket in finish corral. Failure to do so will result in a \$5 replacement fee charge.
8. Event Staff are present to insure the safety and "fun factor" of all runners. Please respect decisions made by them. All decisions made by the Race Officials in dealing with conduct of runners on the course are final.
9. No dogs (except guide dogs with credentials) will be allowed on the race site for any reason.
10. Event will occur rain or shine. There are no refunds available.
11. Most importantly; be safe, be courteous, and enjoy the run!

## RELEASE

**In consideration of participating in the Alcona County Fair Mud Run, and for other good and valuable consideration, I hereby agree to release and discharge from liability arising from negligence: A2 Race Management and the Alcona County Fair, and its owners, directors, officers, employees, agents, volunteers, participants, and all other persons or entities acting for them (hereinafter collectively referred to as "Releasees"), on behalf of myself and my children, parents, heirs, assigns, personal representative and estate, and also agree as follows:**

1. I acknowledge that the ALCONA MUD RUN involves known and unanticipated risks which could result in physical or emotional injury, paralysis or permanent disability, death and property damage. Risks include, but are not limited to running, climbing, rolling, medical conditions resulting from physical activity; and damaged clothing or other property. I understand such risks simply cannot be eliminated, despite the use of safety equipment, without jeopardizing the essential qualities of the activity.
2. I expressly accept and assume all of the risks inherent in this activity or that might have been caused by the negligence of the Releasees. My participation in this activity is purely voluntary and I elect to participate despite the risks. In addition, if at any time I believe that event conditions are unsafe or that I am unable to participate due to the physical or medical conditions, then I will immediately discontinue participation.
3. I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless the Releasees from any and all claims, demands, or causes of action which are in any way connected with my participation in this activity, or my use of their equipment or facilities, arising from negligence. This release does not apply to claims arising from intentional conduct. Should Releasees or anyone acting on their behalf be required to incur attorney's fees and costs to enforce this agreement, I agree to indemnify and hold them harmless for all such fees and costs.
4. I represent that I have adequate insurance to cover any injury or damage I may suffer or cause while participating in this activity, or else I agree to bear the costs of such injury or damage myself. I further represent that I have no medical or physical condition, which could interfere with my safety in this activity, or else I am willing to assume - and bear the costs of - all risks that may be created, directly or indirectly, by any such condition.
5. In the event that I file a lawsuit, I agree to do so solely in the state where the Releasees' facility is located, and I further agree that the substantive law of that state shall apply.
6. I agree that if any portion of this agreement is found to be void or unenforceable, the remaining portions shall remain in full force and effect.
7. I know that running is a potentially hazardous activity. I should not enter and run unless I am medically able and properly trained. I agree to abide by any decision of a race official relative to my ability to safely complete the run. I hereby certify that I am in good health and I have trained to run the distance of the race, which I am entering. I assume all risks associated with running in this event including, but not limited to: falls, contact with other participants, the effects of weather, including high heat and/or humidity, traffic and the conditions of the road, all such risks being known and appreciated by me.
8. I grant permission to all of the foregoing to use any photographs, motion pictures, recordings, or any other record of this event for any legitimate purpose. I understand that bicycles, skateboards, roller skates or inline skates and animals are not allowed in the event and I will abide by this policy.
9. I authorize any healthcare provider to release any and all information pertaining to my healthcare, medical condition and medical treatment as a result of my participation in this event to event administrative staff. I acknowledge that I am over 18 years of age and have the legal capacity to grant this waiver, or I am the parent or legal guardian of any registrant and participant under 18 years of age, and have the legal capacity to execute this waiver and release on behalf of the registrant or participant.
10. Additionally, as the parent/guardian of a minor participating in this event, I acknowledge that permission has been granted to said minor. I further agree to indemnify and hold harmless Releasees from any claims alleging negligence which are brought by or on behalf of minor or are in any way connected with such participation by the minor.

**By registering online, I agree that if I (or my minor) am hurt or my/our property is damaged during my/our participation in this activity, then I/we may be found by a court of law to have waived my right to maintain a lawsuit against the parties being released on the basis of any claim for negligence.**

I have also had sufficient time to read this entire document and, should I choose to do so, consult with legal counsel prior to signing. Also, I understand that this activity might not be made available to me or that the cost to engage in this activity would be significantly greater if I were to choose not to sign this release, and agree that the opportunity to participate at the stated cost in return for the execution of this release is a reasonable bargain.
